**Announcement of Completion of Acquisition of Shares (Conversion into Wholly Owned Subsidiary) of
UNY CO., LTD. (Follow-Up on Previously Disclosed Event)**

Don Quijote Holdings Co., Ltd. (the “Company”), announced that it has completed the acquisition of 60% of the shares of UNY CO., LTD. (“UNY”), from FamilyMart UNY Holdings Co., Ltd. (“FamilyMart UNY HD”), and the subsequent conversion of UNY into a wholly owned subsidiary (the “Acquisition”). The Acquisition was initially described in the press release dated October 11, 2018, “Announcement of Acquisition of Shares of UNY CO., LTD. (Changes in the Subsidiary, etc.) and Expression of Opinion regarding Planned Commencement of Tender Offer for Shares in Don Quijote Holdings Co., Ltd. by a Wholly-Owned Subsidiary of FamilyMart UNY Holdings, Co., Ltd.,” and a resolution regarding the Acquisition was made at a meeting of the Board of Directors held on the same day. Also as announced in the aforementioned press release, UCS CO., LTD. (“UCS”), a wholly owned subsidiary of UNY, became a wholly owned subsidiary (sub-subsidiary) of the Company following the conversion of UNY into a wholly owned subsidiary of the Company.
